THE FEE FOR AN EVICTION LASTING ONE DAY (8 HOUR PERIOD), IS \$350.00 **AND IS NON REFUNDABLE ONCE THE 48 HOUR NOTICE IS SERVED.** FOR LAW OFFICES BEING BILLED, THIS FEE WILL BE INVOICED SHOULD THE EVICTION BE CANCELLED AFTER THE 48 HOUR NOTICE IS SERVED.

THE COST OF THE 48 HOUR NOTICE IS DETERMINED BY HOW MANY DEFENDANTS ARE BEING SERVED.

BECAUSE OF STAFFING & SCHEDULING ISSUES, WE ARE LIMITED TO 2-3 EVICTIONS PER WEEK. OUR OFFICE CAN GIVE YOU THE DATES AVAILABLE & YOU WILL NEED TO SECURE A MOVER FROM THE LIST OF STATE APPROVED MOVERS.

IF THE EVICTION LASTS MORE THAN 8 HOURS, YOU WILL BE CHARGED AN ADDITIONAL \$350.00 PER DAY.
